It is a known trend that the number and variety of robotic systems deployed for field work is increasing worldwide. Compared to factory automation robots, these field robots generally operate in semi-structured or sometimes unknown environment. They are mostly purpose-built for specific tasks, with their development project mainly commissioned by the relevant industry with university collaborations. In Switzerland, there are multiple project phases over several years that developed inspection robots for equipment such as steam chests, generators, and boiler tubes inside power plants [1]. Other examples are inspection robots for power transmission lines by a hydroelectricity utility provider in Canada [2] and for marine vessels by a European industry and university collaboration [3]. Apart from inspection tasks there are also mobile robots designed for maintenance tasks, such as window cleaning for building [4].
