Enterprise Support Scheme		<ul style="list-style-type: none"> provide funding support for in-house R&D up to \$10 million per project on a 1:1 matching basis you own the intellectual property (IP) you may request an advance payment of up to 50% of the approved matching funding for the first 6 months or up to \$500,000, whichever is the lower
(b) Working with R&D Centres and Designated Local Public Research Institutes		
Innovation and Technology Support Programme		<ul style="list-style-type: none"> support applied R&D projects undertaken by R&D Centres, universities or designated local public research institutes as well as R&D projects undertaken by R&D Centres or designated local public research institutes in collaboration with companies you contribute at least 10% of the total project cost for platform projects, the remaining amount would be contributed by the Innovation and Technology Fund you contribute at least 50% of the total project cost for collaborative projects (at least 30% for projects undertaken by R&D Centres), the remaining amount would be contributed by the Innovation and Technology Fund if you contribute at least 50% of the total project cost, you own the IP; if you contribute less than 50% of the total project cost, you may still enjoy favourable terms in using project results commensurate with the level of your contribution, such as early access to the R&D outcomes, discount in future licensing fees, etc.

Patent Application Grant	<ul style="list-style-type: none"> • supports first-time patent applications by locally incorporated companies, Hong Kong permanent residents or Hong Kong residents permitted to remain in Hong Kong for not less than 7 years for their own inventions • up to \$250,000 per approved case
Research Talent Hub	<ul style="list-style-type: none"> • supports the engagement of up to four research talents by <ul style="list-style-type: none"> - enterprises/organisations undertaking R&D projects under (I)(a) and (b) above - incubatees and I&T tenants of the HKSTPC and Cyberport - technology companies conducting R&D activities in Hong Kong • maximum monthly allowance : <ul style="list-style-type: none"> - Bachelor: \$20,000 - Master: \$23,000 - Doctor: \$35,000, plus \$10,000 living allowance • the maximum funded period of each research talent is 36 months • in addition to the quotas of engaging four research talents, supports the engagement of up to 36 additional research talents by enterprises undertaking NIAS projects. The maximum funded period is 3 years and up to half of the monthly salary or half of the RTH maximum monthly allowance will be funded per talent,

New Industrialisation and Technology Training Programme	<ul style="list-style-type: none"> • supports enterprise to train their staff in advanced technologies, especially those related to “New Industrialisation” • up to \$500,000 per enterprise per year • on a 2 (Government) : 1 (enterprise) matching basis • you may request an advance disbursement of up to 50% of the approved training grant before the completion of training course
(IV) Specifically For Technology Start-ups	
Innovation and Technology Venture Fund	<ul style="list-style-type: none"> • co-invests with venture capital funds in local I&T start-ups on an approximately 1 (Government) : 2 (venture capital fund) matching ratio (up to 40% of total investment amount sought by the investee company or \$30 million per deal, whichever is the lower) • also launches the Innovation and Technology Venture Fund enhanced scheme to set up funds jointly with the market, on a matching basis, to invest in start-ups of strategic industries
Technology Start-up Support Scheme for Universities	<ul style="list-style-type: none"> • provides an annual funding of up to \$16 million to each designated university to support their teams in starting technology businesses, of which the amounts of funding provided on a non-matching basis and on a 1 (Government) : 1 (private investment) matching basis are both capped at \$8 million • up to \$1.5 million per start-up per year for no more than six years (three years each on non-matching and matching bases)
Research, Academic and Industry Sectors One-plus Scheme	<ul style="list-style-type: none"> • supports local universities in transformation and commercialisation of R&D outcomes in two stages: <ul style="list-style-type: none"> - The First Stage (transformation and realisation of R&D outcomes): providing funding support up to 2 (Government) : 1 (industry and university) matching basis - The Second Stage (initiation of commercialisation of R&D outcomes): on a 1 (Government) : 1 (industry) matching basis

	<ul style="list-style-type: none"> • depending on the maturity of the transformation of its R&D outcomes, applicant (must be a university funded by the University Grant Committee) may join the Scheme starting from either the first or the second stage • up to \$100 million per project • university teams/inventors should be entitled to no less than 70% of the IP benefits (for IPs generated by the teams/ inventors during the project period)
